Tuition

Tuition for Extension Courses is **\$585** without discounts or waivers. We offer many different types of discounts and waivers, look below to see if you qualify for a discount or waiver:

New Student Waiver

If you have never attended an Extension Course in the past, you are eligible to receive a one-time waiver of \$225 when you register for your first Extension Course. (Cannot be combined with the Early Registration Discount)

Early Registration Discount

To be eligible to receive a \$225 Early Registration discount you must register by June 27, 2008.

Multiple Seminar Waiver

If you register for more than one Extension Course in a given semester, you will receive a \$60 waiver for *each* course.

Spouse Discount

If you and your spouse register for an Extension Course in a given semester, you will receive \$60 off of *each* course. A savings of \$120 per couple.

Registration

Registrations should be postmarked no later than July 11th to avoid the \$75 late registration fee. Members of the public are welcome to audit George Wythe College courses. To receive college credit, however, students must be accepted into a degree program prior to registering for courses. Please see our website for additional information about the admissions process. Instructors

Extension Course instructors are either full-time or part-time GWC faculty members.

2008 Off-Campus Extension Course Refund Policy

All enrollments are subject to a three business day cooling-off period, commencing with the day an initial deposit or payment toward tuition of the institution is made, until midnight of the third business day following such date, during which time the contract may be rescinded and all monies paid refunded. A written statement of withdrawal received by George Wythe College or postmarked before midnight of the third business day, shall be deemed as meeting the terms of the cooling-off period.

In order to receive a refund, any enrolled student who is dismissed or who withdraws following the cooling-off period must submit a written statement of withdrawal and refund request. George Wythe College shall retain \$75 of tuition and/or fees as a nonrefundable registration charge. A percentage of all tuition/fees paid, or scheduled to be paid, over and above the nonrefundable registration fee shall be refunded for the current academic period within thirty days of his/her discontinuing. All monies shall be refunded according to the Tuition Refund Schedule below.

Tuition Refund Schedule

Once the cooling-off period has passed, tuition is partially refundable to students who request it in writing. GWC will observe the following schedule for refunding tuition/fees:

<i>Date of Withdrawal of the Enrollment Period for Which the Student Was Obligated</i>	<i>Portion of Tuition and Fees Obligated and Paid that are Eligible to Be Refunded to the Student</i>
Within the three business day cooling-off period:	100%
Prior to Semester start date:	90% (minus the non-refundable registration charge)
Within the first 6 business days of the semester:	75% (minus the non-refundable registration charge)
Within the next 5 business days of the semester:	25% (minus the non-refundable registration charge)
Within the next 5 business days of the semester:	10% (minus the non-refundable registration charge)
